A separate application should be completed for each child in a family, although Sections 3 and 4 only need to be completed once per family. The application may be completed by hand or electronically. All documents included in support of the application must be submitted at the same time as the application.

#### Section 5. Campership Award Applicant Expression of Interest

All Campership Award Applicants applying for an Indian & Forest Acres Scholarship Foundation Campership Award must submit an expression of interest that covers the following topics:

- Why they wish to attend Indian Acres or Forest Acres;
- What they hope to accomplish and learn from their time at camp;
- What kinds of activities interest them and why;
- How they feel about being away from home for seven weeks; and
- How they feel about living in a cabin with several other children, and two counselors.

This information can be submitted in any form that suits the Campership Award Applicant: video, collage with pictures explained, short essay, story, song, etc.

Please make sure the Campership Award Applicant has had an opportunity to learn about Camp through the Camp website, conversations with those affiliated with Camp, or in some other manner, so that they are able to respond to these prompts thoughtfully.

#### Section 6. Parent/Guardian Statement (required) and Sponsor Statement (as applicable)

The <u>Parent/Guardian</u> of Campership Award Applicant(s) applying for an Indian & Forest Acres Scholarship Foundation Campership Award must submit a statement detailing:

- Why the Applicant should have an opportunity to attend Indian Acres or Forest Acres;
- What you hope the Applicant will accomplish and learn from their time at camp;
- What experiences or qualities the Applicant has, or has had, that prepare them for seven weeks away at sleepaway camp;
- What parts of the Applicant's personality or demeanor make them a good fit for sleepaway camp; and
- Any special concerns or circumstances we should be aware of, including social, emotional or health issues, family or custody issues, or anything else that could impact the Applicant's ability to thrive at camp.

If for any reason the Parent/Guardian is unable to write the statement personally, the Sponsor or other adult may assist in preparing the thoughts of the Parent/Guardian. The statement does not have to be in English. The statement may be of any length.

<u>If a Sponsor is presenting the Campership Award Applicant for a Campership Award</u>, the Sponsor must ALSO provide a statement covering the same set of information listed above.

#### Section 7. References

Please submit two (2) references in support of the Campership Award Applicant. The references can be from anyone with direct, personal knowledge of the Applicant's personality, demeanor, and behavior.

If the Campership Award Applicant is being supported by a Sponsor (as discussed above, Section 2), the Sponsor may **not** be one of the two (2) references. The Sponsor must submit a separate statement.

References should be approximately one (1) typed page, though longer is fine. References should discuss at least the following topics, though additional information is welcome:

- The Applicant's personality, demeanor, behavior, and/or interests;
- Why the writer believes the Applicant should be awarded a Campership Award to attend Camp; and
- What makes the writer confident that the Applicant will thrive at a 7-week sleepaway camp.

#### Section 8. School Recommendation Form

Please have a teacher or counselor from the Campership Award Applicant's school complete the form located at <u>this link</u>. The teacher or counselor completing the form should have direct knowledge of the Applicant's personality, demeanor, and behavior, based on the current 2025-2026 school year or the past 12 months.

This form will be submitted directly to The Foundation's Board and will not be collected by the Applicant directly.
